

2024 FX COSMO Terms & Conditions

1. Introduction

These Terms and Conditions govern the use of FX COSMO's services, including but not limited to digital marketing, affiliate marketing, Introducing Broker (IB) services, promotions, seminars, events, and expos. These services are offered to associated forex brokers, clients, affiliates, sub-affiliates, associates and partners. 2. Definitions

7. Intellectual Property Rights

All intellectual property (IP) related to FX COSMO's services, including trademarks, logos, proprietary information, and marketing materials, remains the sole property of FX COSMO. Affiliates, clients, IBs, partners, and associates are prohibited from using FX COSMO's intellectual property without prior written permission.

- 12.2. If the cancellation is made after the thirty (30) days from the date of ticket purchase, no refund will be provided, and FX COSMO will retain the full payment.

- 12.4. FX COSMO reserves the right to alter or cancel the event due to unforeseen circumstances, in which case participants will receive a full refund of the event fees paid.
